EXECUTIVE SUMMARY

This Surveillance 1 Audit (2017) on the Anap Muput Forest Management Unit (FMU) was conducted on 3 – 6 July 2017 to assess the continued compliance of the overall forest management system of the FMU against the requirements of the *Malaysian Criteria and Indicators for Forest Management Certification (Natural Forest)* [MC&I (Natural Forest)] using the verifiers stipulated for Sarawak. The scope of this surveillance audit was limited to the forest management system and practices on the Anap Muput FMU which was classified as Permanent Forest Estate (PFE) under the Anap Protected Forests constituted on 1st March 1958 under Notification No. 587, gazetted on 1st September 1956 (No. 1102).

This surveillance certification audit was conducted by a 3-member team comprising Mohd Razman Salim (Lead Auditor), Khairul Najwan Ahmad Jahari (Auditor) and Tn. Hj. Roslee Jamaludin (Auditor).

This surveillance audit had resulted in the issuance of four (4) Major and six (6) Minor Non Conformity Requirements (NCRs). There was no Observation for Improvement (OFI) raised. Based on the findings of this surveillance audit, and following the acceptance of the corrective actions taken to close the major NCRs and the plans to close the minor NCRs, it was found that the Anap Muput FMU had continued to comply with the requirements of the MC&I (Natural Forest).

This public summary contains the general information on the Anap Muput FMU, the findings of the surveillance audit, NCRs raised, the corrective actions taken as well as the decision on the continued certification of the FMU.

2.3 General Background on the Anap Muput FMU

The Anap Muput FMU is managed by Zedtee Sdn Bhd (Zedtee) under Timber Licence No. T/4317 which expires on 8 March 2024. Zedtee is committed in the management of the FMU on a sustainable basis. The FMU is bounded by Sg. Muput Kiba to the north; Sg. Malat and Sg. Anap to the east; Sg. Belawit to the southeast; Bt. Maleng, Bt. Obar and Bt. Likang mountain ridges on the south and the cut-line common boundary with Licence No. T/3393 to the west.

The Anap Muput FMU covers an area of 83,535 hectares which covered 0.67 % of total area of Sarawak State. The FMU is located between latitudes 2°08' and 2°32'N, and longitudes 112°37' and 113°E in the Tatau District of Bintulu Division. Forest type covered in the FMU area ranges from lowland dipterocarp forest to hill dipterocarp forest with elevation from less than 100m to 900m above sea level.

The FMU was classified as Permanent Forest Estate (PFE) under the Anap Protected Forests (76,935 hectares) constituted on 1st March 1958 under Notification No. 587 and Mukah Hills Protected Forests (6,600 hectares) gazetted on 1st September 1956 (No. 1102) and 13th June 1958 (No. 790). During this Surveillance 1 audit, the Anap Muput FMU has remained unchanged in its area coverage under the respective gazettements.

A map of the FMU showing the significant features of the forest is attached in Attachment 1.

2.4 Date First Certified 25 July 2013

2.5 Location of the FMU

The FMU is located between latitudes 2°08' and 2°32'N, and longitudes 112°37' and 113°E in the Tatau District of Bintulu Division.

2.6 Forest Management System

The revised Forest Management Plan 2011-2024 dated 11 January 2011 for Anap Muput FMU had incorporated all the items listed from a) to i) in Criterion 7.1 of the MC&I (Natural Forest). The FMU completed the fifth revision to the FMP titled 'Forest Management Plan for Anap Muput (2017 - 2024)' on 1 December 2016 which was approved by Sarawak Forest Department on 19 December 2016 covering the remaining seven years of the harvest period of 2017-2024. The certified area is managed towards Sustainable Forest Management with 25-year cycle.

2.7 Annual Allowable Cut/Annual Harvest under the Forest Management Plan

The AAC as approved by the Sarawak Forestry Department for Anap Muput FMU, in August 2016, was 3,125 ha (for coupe 18/2017), 2,168 ha (coupe 19/2018) and 3,502 ha (coupe 20/2019). The AAC calculation as shown in the revised Anap Muput FMP gave an estimate on yield in logs volume at 75% harvest efficiency which is 1.5 m3/ha/year, and estimated yield per annum at 125,302 m³.

2.8 Environmental and Socioeconomic Context

An EIA report for the "Re-entry Hill Logging Within the Anap-Muput FMU Under Timber Licence No. T/4317 and LPF/0039, Bintulu and Sibu Divisions Sarawak" was produced as required under the Natural Resources and Environment (Prescribed Activities) Order 1994. The potential impacts and strategies to mitigate the impacts were written in this document.

The EIA was approved on 26 November 2008 by the Natural Resources and Environment Board (NREB), reference no. (20) NREB/6-3/2G/18 with conditions to be implemented by the FMU. It had specified quarterly environmental monitoring every year and reports to be submitted to NREB. With this requirement an *Environment Management Plan (EMP)* for the Re-entry Logging Within Coupe 15 to 19 in the Anap Muput Forest Management Unit Under Forest Timber Licence No. T/4317 Bintulu and Sibu Divisions Sarawak September 2013 was written.

Protection through enforcement of no hunting policy had been implemented in accordance to Wildlife Protection Ordinance 1998. The circular DF 6/99 from the FDS's Director banning all hunting by employees of the FMU, no selling of wild meat and closing of feeder roads on completion of harvesting activities was posted in the office at the base camp.

The FMU had formulated the Anap Sustainable Development Unit (ASDU) together with the FDS and SFC through a Memorandum of Understanding for both the Anap Muput FMU and including the LPF/0039 areas. An ASDU Liaison Committee (ASDULC) comprising representatives from Sarawak Forestry Corporation, Forest Department, FMU and local community Conservation and Community Development (CCD) committees had been established to serve as a forum for consultation by members and to arbitrate social problems affecting the FMU as guided by the FMU CCD Committee.

There was no issue on disputes that required resolution by the Native Courts or Civil Courts. It was confirmed during the consultation with Tuai Rh. Gasah, at Rh. Sayong, Rh. Entrie, Rh. Bilong, and Rh. Philips.

Actions taken by FMU to prevent or mitigate adverse impacts included marking of sites for shifting agriculture, burial ground and water catchment in the Forest Zonation and General Harvesting Plan of Anap Muput FMU (T/4317) dated 20 March 2014. Discussion with the Tuai Rumah (headmen) of Rh. Philip, and villagers outside/bordering with the FMU at Rh.Sayong, Rh. Gasah, Rh. Enteri and Rh. Bilong during this audit confirmed that their *Temuda* and water catchment areas were not affected by forest management practices.

The FMU had given preference for employment and contract works for qualified people in communities living within or adjacent to the FMU area. Record 'Distribution of household with residents on Zedtee SB payroll' inspected showed a total of 26 workers from Rumah Entrie (2), Rumah Bilong (2), Rumah Gasah (1), Rumah Mawang (20), and Ph. Philip (1) were hired in camp administration, workshop, store, survey, log pond & transit, road repair, road construction, trucking, hauling and felling operations.

3.3 Standard Used

Malaysian Criteria and Indicators for Forest Management Certification (Natural Forest) [MC&I (Natural Forest)] using the verifiers stipulated for Sarawak.

3.4 Stakeholder Consultations

A stakeholder notification was issued in June 2017 for a period of one month for comments on management of the FMU. However, there was no response from the stakeholders notified within the specified period.

In addition to the above, consultations with stakeholders were also carried out during the audit as indicated in Attachment 3.

3.5 Audit Process

The audit was conducted primarily to evaluate the level of continued compliance of the Anap Muput FMU's current documentation and field practices in forest management with the standard of performances (SOPs) listed in the MC&I (Natural Forest), using the verifiers stipulated for Sarawak.

For each Indicator, the auditors had conducted either a documentation review, consultation with the relevant personnel of the FMU, local community or stakeholders or field audit or a combination of these methods. Depending on the compliance with the verifiers for a particular indicator, the auditors then decided on the degree of the FMU's overall compliance with the indicator and decided whether or not to issue a major or minor NCR or an OFI which is defined as follows:

- (i) A major NCR is a non-compliance with the requirements of the MC&I (Natural Forest).
- (ii) A minor NCR is a deviation or a lapse in complying with the requirements of the MC&I (Natural Forest).
- (iii) An OFI is a situation where the auditor has noted an area of concern on the capability of the forest management system to achieve conformance to the requirements of the MC&I (Natural Forest) but without sufficient objective evidence to support a non-conformance.

Consultations were held with the Tuai Rumah (headmen) of Rh. Philip, and villagers outside/bordering with the FMU at Rh.Sayong, Rh. Gasah, Rh. Enteri and Rh. Bilong The audit team had also held meetings with the officers and the uniformed field staff of the SFD.

The coverage of this surveillance audit is as shown in the surveillance Audit Plan in Attachment 3.

4 SUMMARY OF AUDIT FINDINGS

Based on the findings of this Surveillance 1 audit, Zedtee Sdn.Bhd. had continued to manage the Anap Muput FMU in compliance with the requirements of the MC&I(Natural Forest). This surveillance audit had resulted in the issuance of four (4) Major NCR and six (6) Minor NCRs. The details on the NCRs raised are shown in **Attachment 4.**

The audit team had reviewed the corrective actions taken by the FMU to address the one (1) Major NCR, three (3) Minor NCRs and three (2) OFIs raised during the previous Recertification Audit in

2015. The actions taken to address the NCRs raised were duly accepted and the non-compliance therefore considered closed. The responses made by the audit team leader on the corrective actions and on the final status of the NCRs are provided in **Attachment 5**.

On indigenous peoples' rights, there were appropriate mechanisms employed to resolve disputes over tenure claims and use rights of the local communities through the operation of Anap Sustainable Development Unit Liaison Committee (ASDULC) framework. This was confirmed through consultation with the local community and as verified through minutes of committee meetings on 26 May 2016 and 15 March 2017.

During this Surveillance 1 audit, the Anap Muput FMU has remained unchanged in its area coverage of a total 83,535 ha PEF under gazettement between Anap Protected Forests (76,935 ha) and Mukah Hills Protected Forests (6,600 ha).

With regard to Criterion 6.10, there was no new conversion of the PFE to forest plantations or other non-forest land uses during the intervening period since the last audit.

Based on the findings gathered during the audit, the Anap Muput FMU had continued to conform to the requirements of the MC&I (Natural Forest). And since all nonconformities have been closed out through verification of records of corrective actiontaken, the assessment team therefore recommends that the Anap Muput FMU continue to be certified against the MC&I (Natural Forest).

The summary on the findings of the surveillance audit on the Anap Muput FMU against the requirements of the MC&I (Natural Forest) are as follows:

	The forest managers were found to be aware of all the binding international agreements and their main intentions on forest management such as the United Nations Agreement on Biological Diversity, 1992 and International Tropical Timber Agreement, 1994.	
	The Conflict Resolution Guidelines for Sustainable Forests Management was sighted at the Muput Base Camp. The FMU had also written to Sarawak Forest Department and Sarawak Timber Association regarding potential conflicts and possible resolution. The forest managers had also expressed their willingness to participate in any conflict resolution. The FMU is legally protected by provisions in nine (9) relevant regulations as listed out and sighted during audit. Boundary assessment using helicopter, as measure in controlling encroachment, was verified through Heliborne Surveillance Report, June 2017.	
	The FMU management was committed to forest certification through a policy entitled <i>Policy Statement of Sustainable Forest Management of Anap Muput FMU</i> to undertake forest management certification under <i>MC&I (Natural Forest)</i> . The statement was available on FMU website - www.anapmuputfmu.com.

S	or civil court cases pertaining to legal customary tenure in the FMU at the time of audit. There was no land claim from villagers who lived outside or bordering the FMU as verified during interview conducted at Rh. Sayong, Rh. Entrie, Rh. Michael Agul, Rh. Bilong, Rh. Marayang, Rh. Danggat, Rh. Sili and Rh. Suah as well as officers of SFC and FDS. The FMU had acknowledged use rights regarding shifting agriculture and water catchment area within the FMU. Mechanisms for resolving land claims were recognized, such as the Anap Sustainable Development Unit (ASDU) established in cooperation with the FDS and SFC for both the Anap Muput FMU and the LPF/0039 areas.	
	User rights of local communities were recognized and the areas concerned demarcated within the FMU on the Forest Zonation and General Harvesting Plan of Anap Muput FMU (T/4317) dated 20 March 2014. The area included longhouses in and around the Anap-Muput Forest Management Unit (FMU) Area, burial ground of villagers of (Rumah Philip), water catchment area for (Rumah Mawang) and all Shifting Agriculture (SA) sites. Records showed that the latest Safety and Health Committee meeting was conducted on 6 March 2017 with representatives from management, forest operations and workers. Summary record of accident (JKKP 8) for year 2016 was reported to DOSH before 31 January 2017 as per requirement. Documents on relevant ILO conventions were available in Muput Camp. Staff employment contracts indicated that they were eligible for rest day, public holidays, sick leave, annual leave, and maternity leave (female employee). Workers' grievances were channelled to the Management Workers Committee for resolution. The SOPs for <i>LR/02 Grievance Procedure dated June 17</i> was sighted. Social impact of forest operations on indigenous and local communities were evaluated through community consultations. A report titled <i>Socioeconomic profiling and agroforestry options among communities within and surrounding the Anap-Muput Forest Management Unit, Tatau, Bintulu Division, Sarawak (2007) covering 19 longhouses was prepared by the FMU. Another document sighted was the <i>Guidelines for community development plan for sustainable forest management in the permanent forest estates of Sarawak (2008)</i>. The FMU has revised the social impact assessment report titled <i>Socio-economic and environmental impact assessment of Ulu Anap communities affected by harvest operations 2014-2024 in Anap Muput Forest Management Unit.</i> The areas used by the local communities were incorporated in forest planning and management. The provisions and measures within relevant federal, state and local laws to prevent loss or damage affecting the local communities' legal or customary rights, property, resources, or their livelihoods were available. These were contained in the <i>Forest Management Plan for Anap Muput FMU (2011-2014) revised 1st December 2016.</i> The main mechanism employed for grievances resolution which provided fair and equitable compensation, caused by impact of forest operations, was the ASDU Liaison Committee (ASDULC).</i>	Consultations with the Anap Muput Committee (AMC) Exco and several Headman and villagers (Rh. Sayong, Rh. Gasah, Rh. Enteri, Rh. Bilong and Rh. Philips), revealed that access roads to their longhouses were not repaired before the Gawai festival as agreed in the ASDU Management Meeting on 6 April 2017. The AMC Exco were also unaware of SOP on grievances by local communities as verified by auditor during. Thus, a Major NCR KN02/2017 for Indicator 4.5.2 was raised.

	RIL was implemented as verified in the harvesting Coupe 17A in active harvesting Block 27. The relevant documents, <i>Guidelines/Procedures on Reduced Impact Harvesting Systems,</i> 1999, Basic Chainsaw Maintenance and Directional Tree Felling 2001, Detailed harvesting Plan and Guidelines for Reduced & Low Impact Logging System in Forest Management Certification (Natural Forest), 2014, were available. The Detailed Harvesting Plan (DHP) and RIL Plan (RILP) of Coupe 17A, Block 27, and License T4317/16/17A clearly marked out the skid trails and feeder roads. The training Programme for 2016/2017 was also sighted. This included training on Safety & Health, Personal Protected Equipment (PPE) and Reduced Impact Logging, among others.	
	The FMU extracted timber from different tree species and processing it into different end products. As stated earlier there was no commercial harvesting of non-timber forest resources except for domestic consumption by the local community.	
	The FMU implemented guidelines to identify and demarcate sensitive areas for the protection of soil and watercourses which included buffer zones. The Management Plan, revised on 1st December 2016 (2017-2024), specified guidelines to maintain the values of forest services highlighted together with the RIL guidelines as specified in Indicator 5.5.2.	
	The AAC, as shown in the revised FMP, estimated log volume yield at 75% harvest efficiency equal to 1.5 m3/ha/year, and estimated yield per annum at 125,302 m³. Closing block summary for the given coupe quantified the number of trees harvested and potential crop trees (PCTs) retained to ensure sustainability. The revised FMP also incorporated similar measures as identified in the EIA study.

Prescribed guidelines for identification and protection of ERT species included the Wildlife Protection Ordinance 1998 and A Master Plan for Wildlife in Sarawak 1996, the Sarawak Plant Red List Dipterocarpaceae on protected tree species, the IUCN Red List of Threatened Species and Guidelines to Identify Endangered and the Rare Threatened Species or Protected Forest Tree Species in Sarawak. Protected ERT trees as well as fruit trees were tagged for protection. There was no salt lick found in the harvesting area audited. The FMU collaborated with other conservation agencies in implementing conservation and management activities. For example the FMU participated in the workshop on Technical Consultation on HoB Corridor Project Implementation Connecting Brunei to Sabah and North Kalimantan through north eastern part of Sarawak at Curtin University Malaysia, Sarawak on 26-27 April 2017. It was coorganized by Sarawak Forest Department, WWF-Malaysia and the university. The FMU instituted a no hunting policy in accordance with the Wildlife Protection Ordinance, 1998. Three FMU members were appointed as Honorary Wildlife Rangers by the Controller of Wildlife of Sarawak. Awareness of ERT species was fostered among workers through notices and posters at Muput Camp. The local community similarly informed was through continuous dialogues and education on conservation organized by the Conservation and Community Development Committee.

The FMU has conducted analysis on change of forest stand composition for PCTs per hectare as verified through Summary Closed Block for Coupe 16A. SFC had established a Checklist for Inspection Prior to Pre-felling Checking. The list serves to detect activities that contravene the Forest Ordinance and Forest Rules, including license conditions and management plan prescriptions. The revised FMP had mentioned guidelines for the conservation of genetic, species and ecosystem diversity in the FMU as stated in the Section 11 Identification and Management of Protection Areas. Detailed Harvesting Plans were prepared taking into consideration biological corridors and buffer zones. These were demarcated for the individual coupe.

Representative areas of existing forest ecosystem were demarcated and mapped for protection consistent with respective FMP criteria and as verified through Forest Zonation & General Harvesting Plan of Anap Muput Forest Management

The audit team found non-conformities on Indicator 6.5.2 as related to (i) Section 2.6 Construction of skid trails, and (ii) Section 2.8 Tree felling, in the Guidelines for reduced and low impact logging systems in forest management certification (Natural Forest) area, 2nd Edition, 2014.

- Width of feeder trail at FT-0-0-10 in Block 27, Coupe 17A was more than 5 meters
- 2. Trees on both side of feeder trail FT-0-0-7 and at temporary logyard at FT-0-0-3 in Block 27, F-1- 16 -1 in block 31 Coupe 17A were pushed down during the road construction.
- 3. One PCT tree (Meranti Merah) with tag number of J08428, 57 cm DBH at FT-0-03, Block 27 in Coupe 17A was felled

Therefore, A Major NCR MRS 03/2017 for Indicator 6.5.2 was therefore raised.

The audit team also found that road construction and drainage requirement were not accordance with the guidelines -3(b)Operational Planning Stage, Guidelines for forest road layout and construction. Road density for harvesting operation exceeded 10 meters per hectare at Coupe 16A and Coupe 17A. No side drain was constructed along feeder road at F-1-16-1 in Coupe 17A. Therefore, a Major NCR MRS 04/2017 for Indicator 6.5.3 was raised.


