#### 1.0 Introduction

#### 1.1 Description of the organization

The Rinwood Pelita (Mukah) Plantation Sdn. Bhd. was established in 2004. It was previously known as Rinwood Sago Plantation Sdn. Bhd. Group members have appointed the Manager of the Sustainability Department of Rinwood Pelita (Mukah) Plantation Sdn. Bhd, as the Group Manager. The group manager and group members (Sebakong-Mukah Estate, Rinwood Pelita Estate or known as Kenyana Estate, Jebungan Oil Palm Plantation Berhad) are located at Mukah Land District area, Sarawak.

Rinwood Pelita POM is also located within the KE. The mill commenced its operation in 2003 with a processing capacity of 40 metric tonnes of fresh fruit bunches (FFB) per hour. In 2006, the mill processing capacity has been increased to 80 metric tonnes of fresh fruit bunches (FFB) per hour. The mill receives about 90% of FFB from the company owned estate i.e. SME, KE and JE, and about 10% from smallholders.

The JE is located within the KE. The estate is administered by KE. The FFB production from the estates i.e. SME, JE and KE were sent to Rinwood Pelita POM for processing into crude palm oil (CPO) and palm kernel (PK). The SME is surrounded with oil palm plantation namely Solar Green estate, Golden Agro Plantation, Estate Pelita Sdn. Bhd. and Delta Pelita Sdn.Bhd. There is a river; Sungai Tisar passes through the Sebakong-Mukah estate. Kampung Sau, Kampung T EH Labak, Kampung Sesok and Kampung Penakub Penakub Ulu and long house namely Rumah Sepakong are among the communities nearby Sebakong-Mukah estate.

In the vicinity of KE, there are long houses namely Rumah Jimbun and Rumah Mawa and other oil palm plantation namely MPI estate, FELCRA and Empire estate as well as Batang Mukah river.

#### 2.0 Audit process

#### 2.1 Audit methodology

The audit was conducted based on sample as defined in the MSPO Certification Requirement for Group Certification. Under this requirement, the sample size was based on the formula  $(0.8\sqrt{y}) \times (z)$ ; where y is total number of group members and z is the risk factor defined by the risk assessment. Based on the risk assessment, two estates have been selected to be sampled. The audit team had visited the field, linesite workshop, chemical store, waste collection areas and other surrounding facilities such as clinic, surau and canteen to verify the implementation of the MSPO MS2530-3:2013. Interviews with the team management, employees, contractors and surrounding estate, relevant government agency and other relevant stakeholders. Apart from the above, records as well as other related documentation were also evaluated. In addition, the audit team has verified the MPOB license and its validity.

It is important to note that the finding from this audit is based on samples taken from the organization activities, procedures, records and interview. Statistically, there is always a possibility that one or more issues/areas will remain unidentified during the course of this audit. The absence of non-compliance in any area or activity does not necessarily imply that no lapses or non-compliance exist.

#### 2.2 Date of next surveillance visit

The surveillance audit will be conducted within 12 months from the decision date.
