1.0 Introduction

1.1 Description of the organization

Sime Darby Plantation Sdn. Bhd, Tennamaram Strategic Operating Unit (SOU) 6 consist of Tennamaram Estate, Bukit Talang Estate and Sungai Buloh Estate. As required by MSPO scheme requirements, this report described MSPO group certification comprise of Tennamaram Estate, Bukit Talang Estate and Sungai Buloh Estate compliance against MS2530-3: General principles for oil palm plantations and organised smallholders. All FFB produce have supplied to Tennamaram palm oil mill.

2.0 Audit process

2.1 Audit methodology

The MSPO initial certification audit consist of stage 1 and stage 2 audit however for SOU 6 the stage 1 audit was waive due to they have obtain RSPO certification with SIRIM QAS International. The Stage 2 audit of Tennamaram SOU 6 was conducted on 4 - 8 on December 2017 where the audit focused mainly on the conformance of the group members against the requirements of certification standard i.e. MS 2530-3: 2013 General principles for oil palm plantations and organised smallholders

The audit was conducted based on sample as defined in the MSPO Certification Requirement for Group Certification. Under this requirement, the sample size was based on the formula $(0.8\sqrt{y}) \times (z)$; where y is total number of group members and z is the risk factor defined by the risk assessment. Based on the risk assessment, the risk factor was determined as low i.e. 1.0 and Tennamaram estate & Bukit Talang estate have been selected to be sampled during stage 2. During Stage 2 audit, the audit team had visited the field, linesite workshop, chemical store, waste collection areas and other surrounding facilities such as clinic, surau and canteen to verify the implementation of the MSPO MS2530-3. Interviews with the team management, employees, contractors and surrounding estate, relevant government agency and other relevant stakeholders. Apart from the above, records as well as other related documentation were also evaluated. In addition, the audit team has verified the MPOB license and its validity.

It is important to note that the finding from this audit is based on samples taken from the organization activities, procedures, records and interview. Statistically, there is always a possibility that one or more issues/areas will remain unidentified during the course of this audit. The absence of non-compliance in any area or activity does not necessarily imply that no lapses or non-compliance exist.

2.2 Date of next surveillance visit

If the group is certified, the next surveillance audit will be conducted within 12 months but not sooner than 9 months from the decision date.

Among the stakeholders consulted included the Department of Environment, Selangor, Department of Occupational and Safety Health, Selangor, BOMBA Bestari Jaya, Immigration Department, Selangor. During the on-site audit, the audit team had also consulted the surrounding estate, contractors, workers' representative and field workers. SIRIM QAS International had initiated the stakeholder consultation by announcing the invitation in the SIRIM QAS International's websites starting from 01 October 2017. Until the completion of on-site Stage 2 audit, there was no comment received for this group members.
