This is to inform that SIRIM QAS International Sdn Bhd (SIRIM QAS International) will conduct recertification audit for forest management certification on Segan FPMU managed by Syarikat Samling Timber Sdn. Bhd.

SIRIM QAS International is a certification body accredited to the Department of Standards Malaysia. This audit will assess the forest management practices of Segan FPMU against the requirements of the MC&I (Forest Plantation) standard related to economic, social and environmental aspects. 4. Stakeholder consultation involving private interviews, discussions or small group meetings with local communities surrounding the FPMU;
5. Closing Meeting with representative of FPMU to present preliminary findings of the audit;
6. Preparation of draft Audit Report describing the audit process, findings and recommendation on certification;

7. Peer review of draft Audit Report by two independent peer reviewers;
8. Submission of final Audit Report to the Head of Food, Agriculture and Forestry Section of SIRIM QAS International; and
9. Disclosure of public summary, if certification is granted to the FPMU.
