The MS 2697:2018 standard defines requirements for the handling, process and recovery for the Repair, Reuse, Recycle and Remanufacture (4R) of vehicle parts and components. Meanwhile the MS 2696:2018 outlines best practices in the provision of Service and Spare Parts (2S).

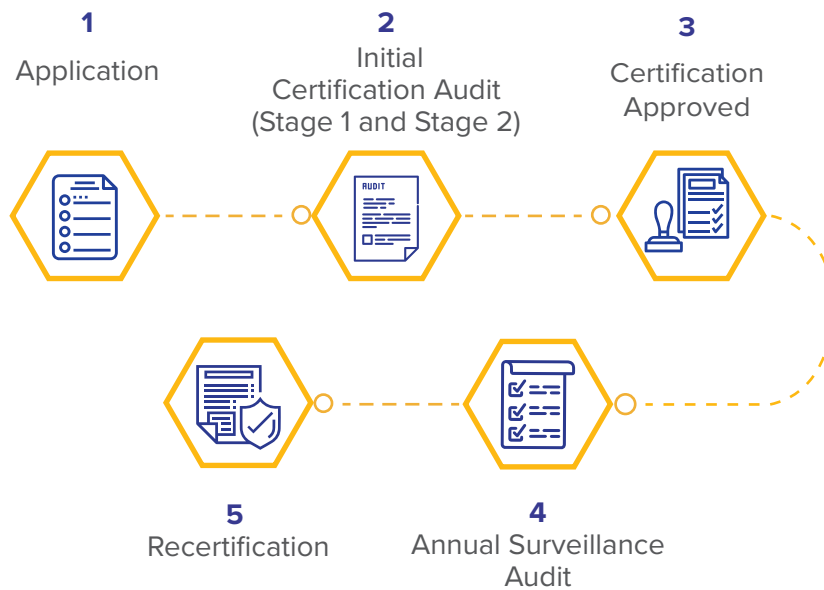
Authorised treatment facilities, workshops and spare parts operators will be guided by optimum standards under 4R2S, ensuring they provide the highest level of service and skill for their clients.
