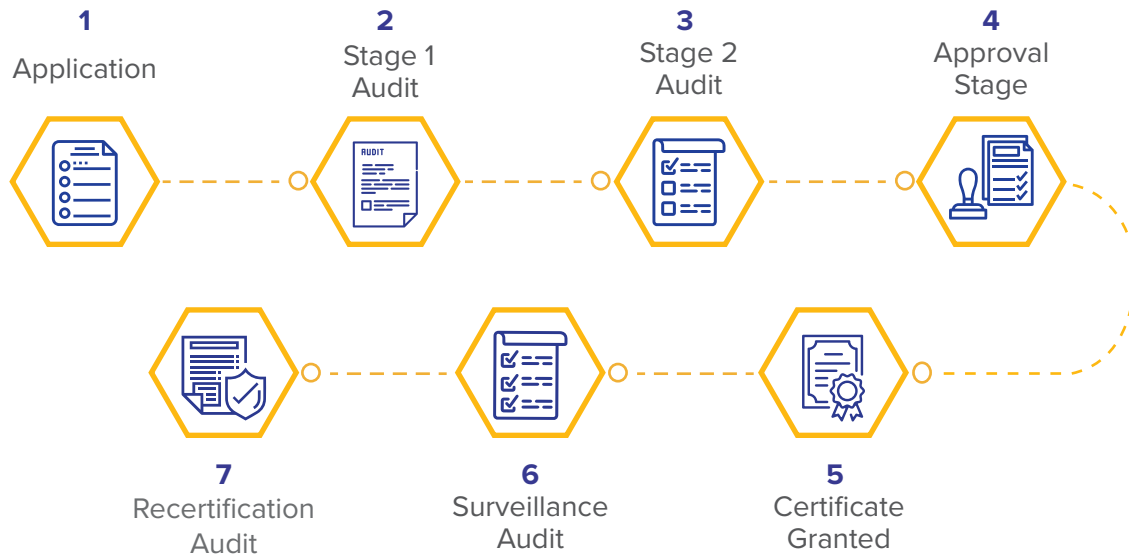
An organisation may minimise the impact of disruption and identify how quickly activities, especially the critical ones, can be restored. This allows organisations to deliver services to customers continuously.
