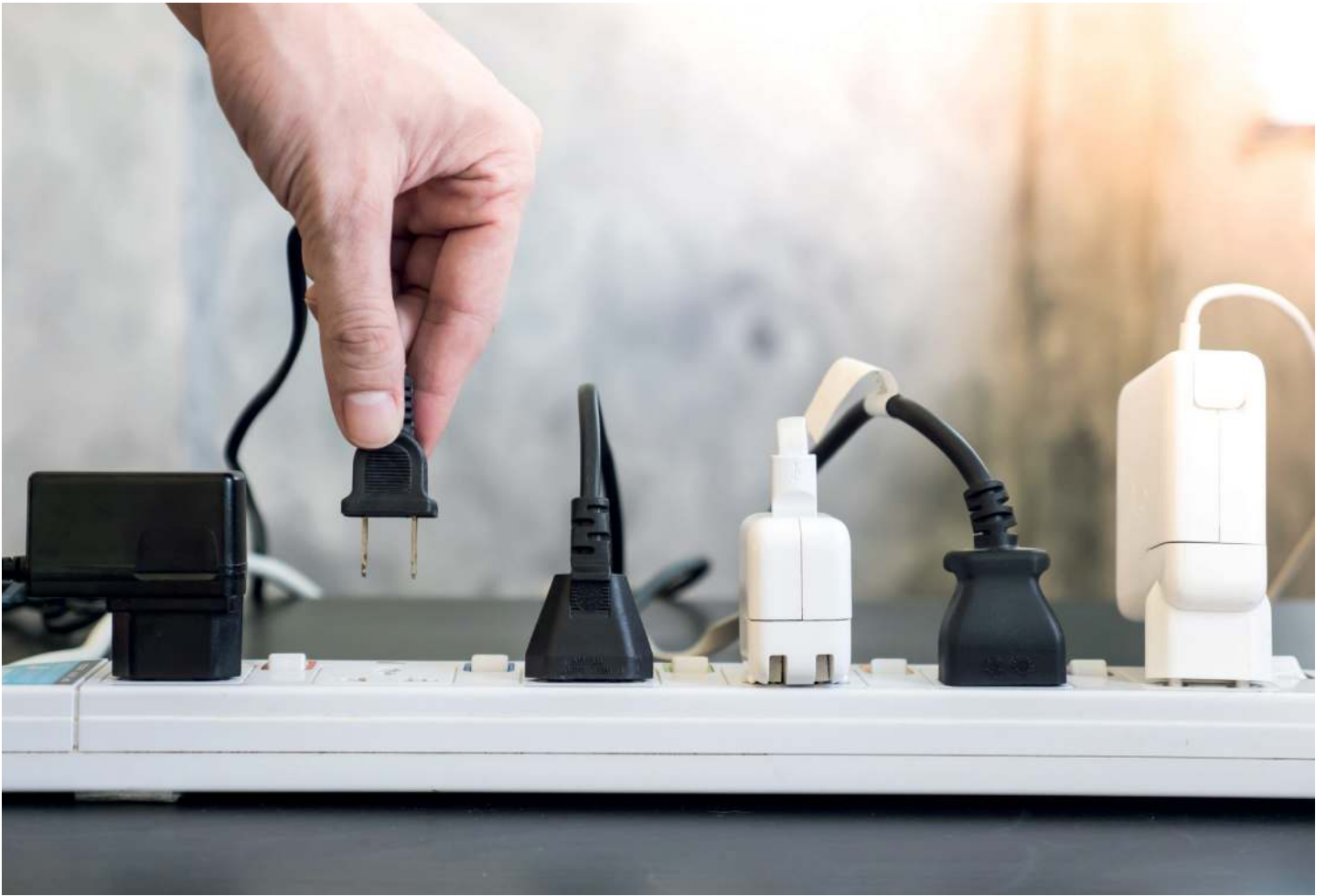

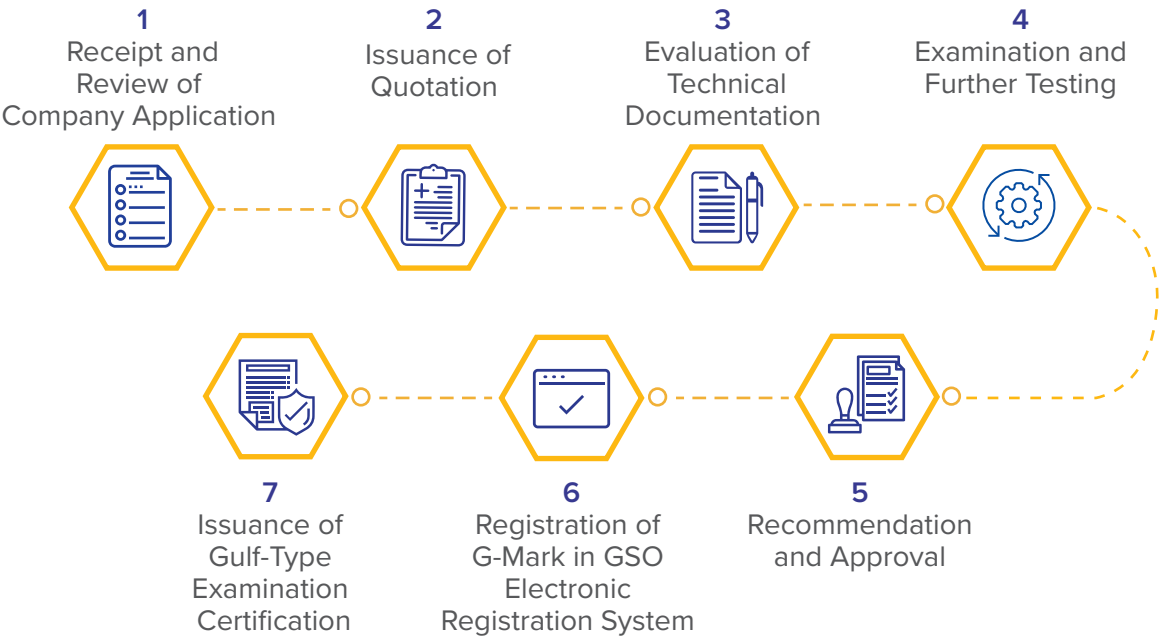

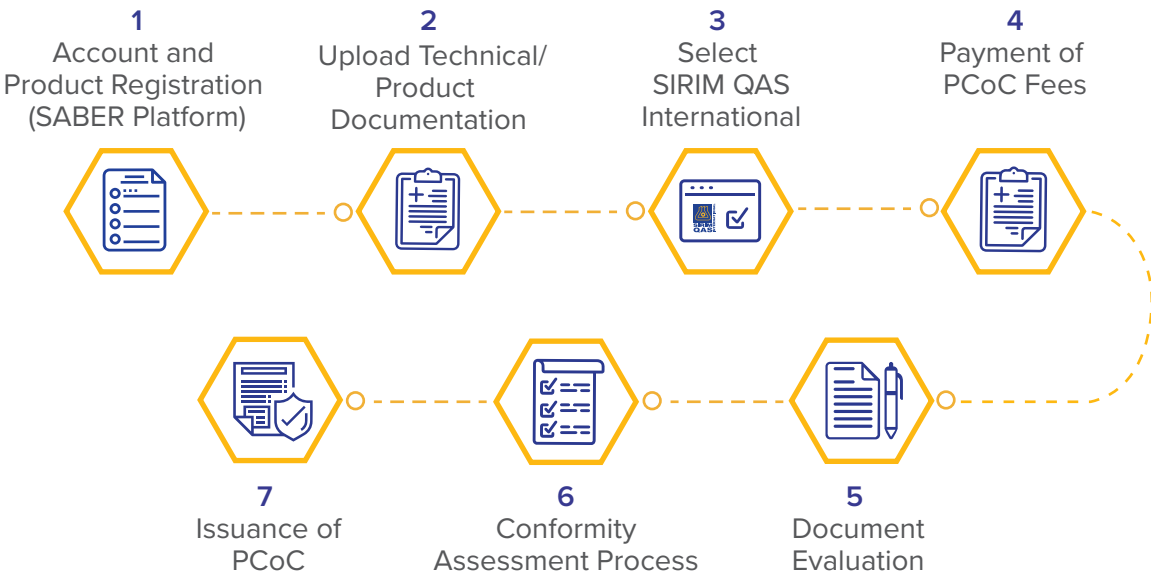
The SASO Certificate of Conformity puts your organisation on a direct path to the wealth and potential of Saudi Arabia’s market. Any product sold in the country must meet specific quality and safety standards. The scheme ensures quality control of raw materials and products, as well as outlines specific procedures of conformity evaluation and certification.

SASO have implemented the Saudi Product Safety Programme (SALEEM) through its SABER system online certification platform. All consignment of regulated products shipments shall obtain a Product Certificate of Conformity (PCoC) and be accompanied with a Shipment Certificate of Conformity (SCoC).

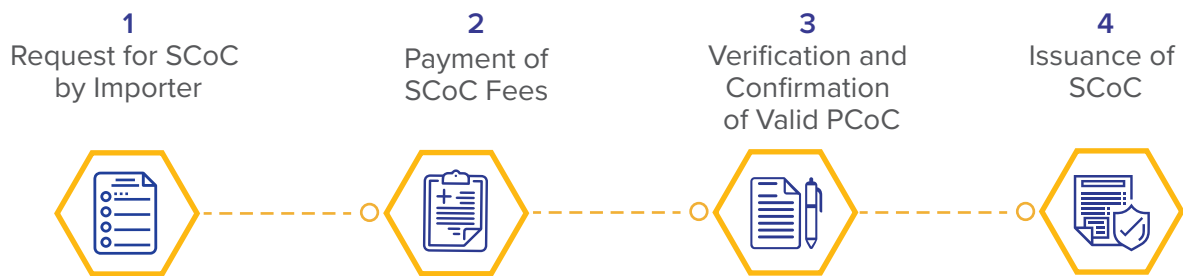
SIRIM QAS International is a certification body accepted and authorised by SASO to issue Certificates of Conformity (CoC) for all applications in a range of Low Voltage Electrical Equipment and Appliance. Importers have to register online on the SABER platform to obtain PCoC and SCoC. Our team of compliance experts are on hand to provide regulatory clarification on market access in Saudi Arabia.
