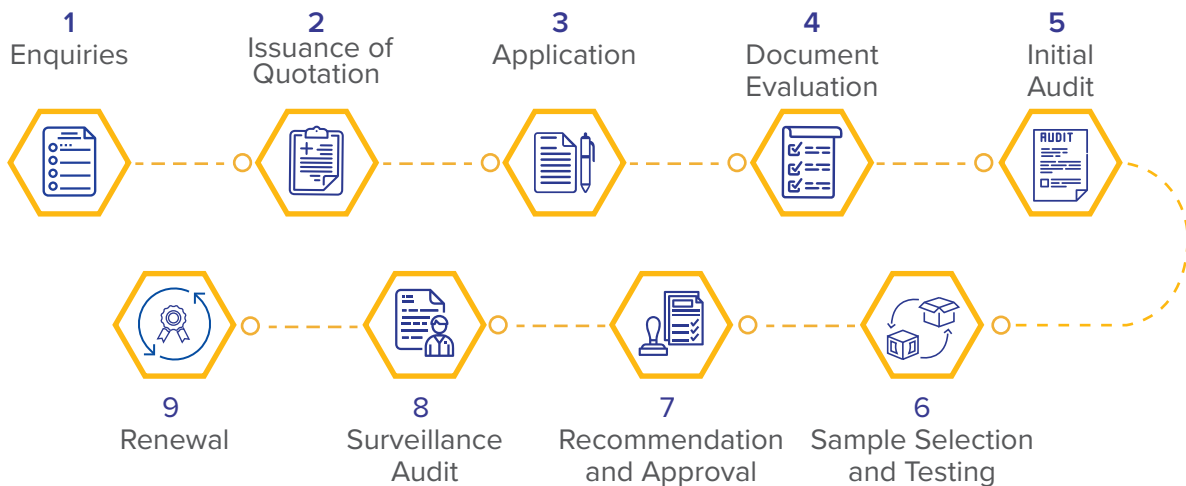

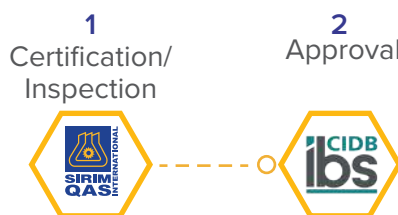
Product Certification and Inspection Process
