

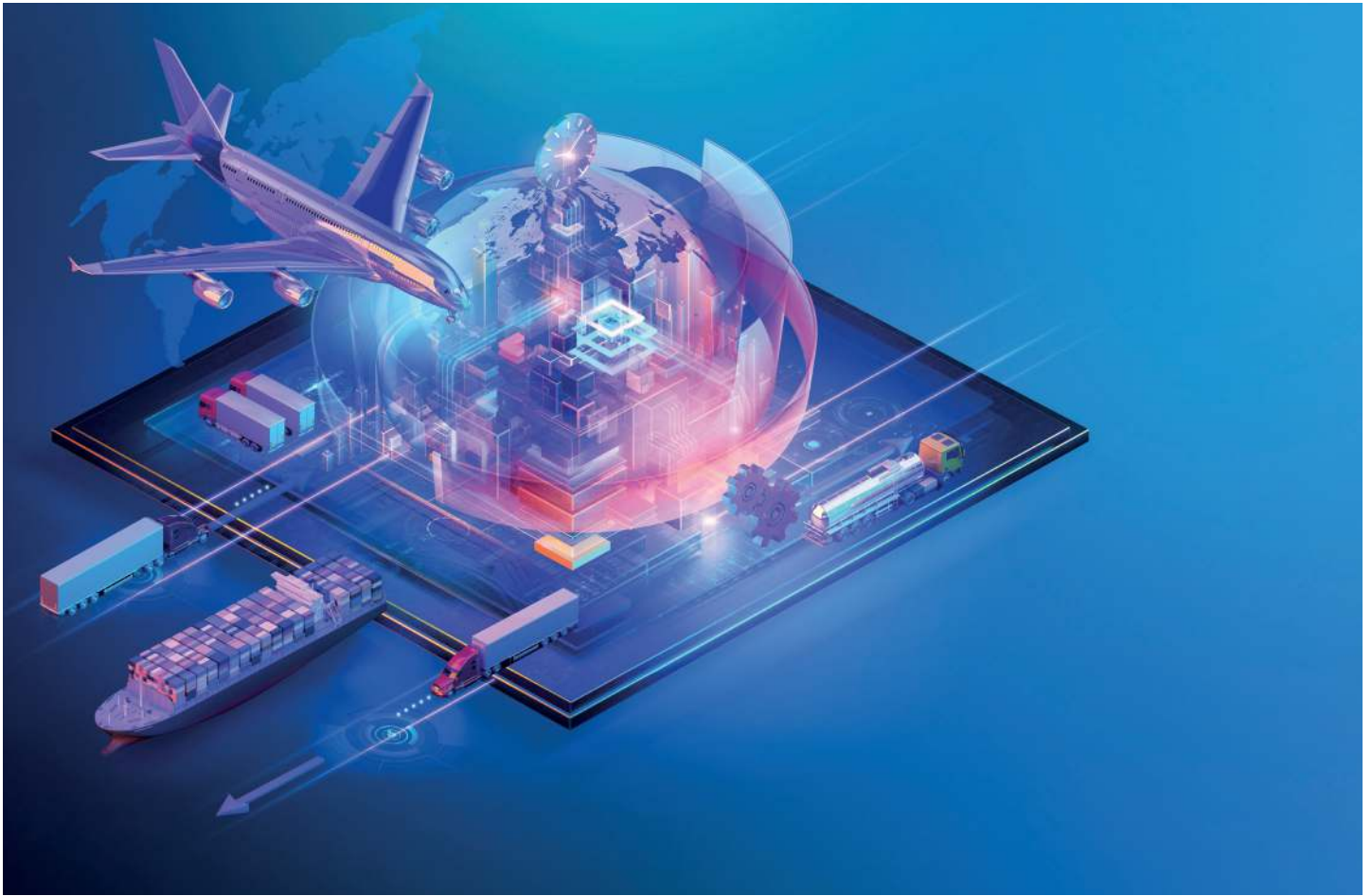

This latest SASO recognition expands the range of services offered by SIRIM QAS International for the regions of Asia and Australia.

The SASO Conformity Certificate puts your organisation on a direct path to the market's wealth and potential of Saudi Arabia. Any product sold in the country must comply with specific quality and safety standards. The scheme ensures quality control of raw materials and products. Importers must register on the SABER platform for PCoC and SCoC. Our compliance team is always ready to provide regulatory clarification on market access in Saudi Arabia.

Gulf Conformity Marking (G Mark) – A Passport to the Gulf Cooperation Countries



The Gulf Cooperation Council (GCC) is a regional intergovernmental union made up of seven Arab countries – the United Arab Emirates, the Kingdom of Bahrain, the Kingdom of Saudi Arabia, the Sultanate of Oman, the State of Qatar, Kuwait, and the Republic of Yemen.

This mandatory G marking also means that the product has passed the adequate conformity assessment before entering the Gulf Market. SIRIM QAS is a notified body to provide a GCC marking scheme to facilitate market access for GCC countries.

CE Marking



CE marking is a conformity mark used to monitor and regulate goods sold in the EU.

CE marking indicates conformity with requirements such as health, safety and/or environmental standards for products sold within the European Economic Area (EEA). CE marking is also found on products sold outside the EEA that have been manufactured in accordance with EEA standards.

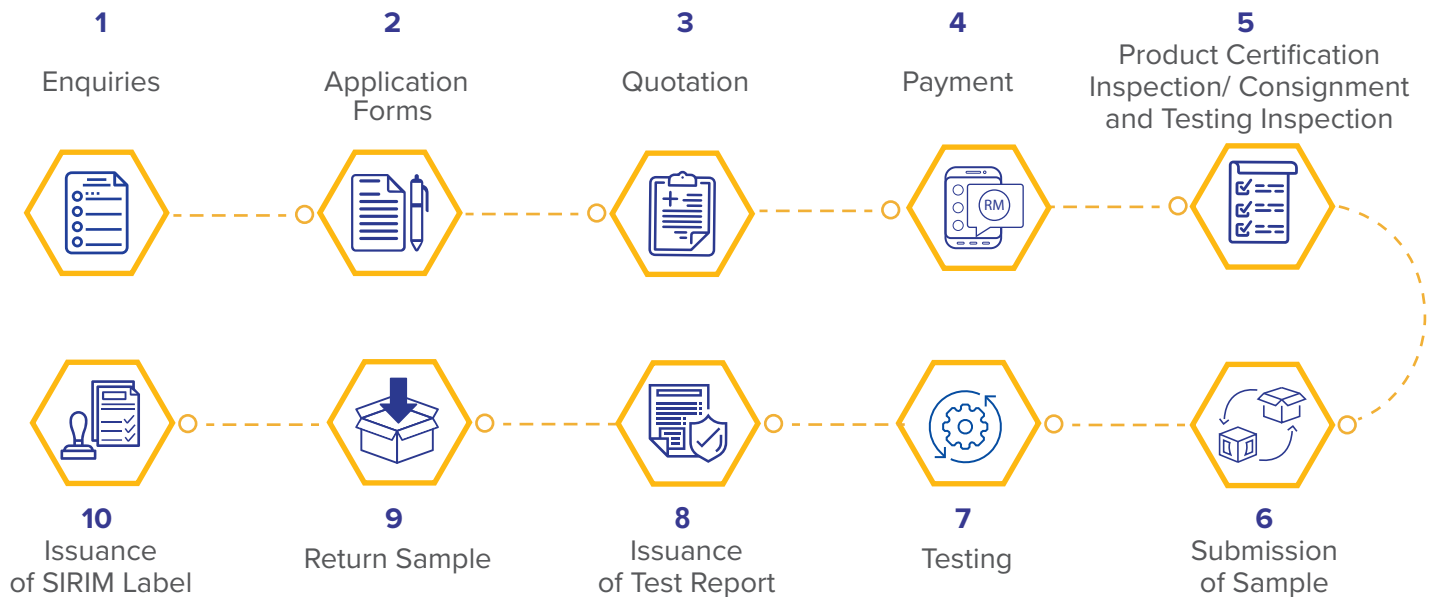
