The World in the Palm of Your Hand – MSPO & MSPO Supply Chain Certification Schemes



Malaysia is one of the world's largest palm oil-producing countries and the industry remains integral to the country's economic growth. However, in recent years, concerns relating to environmental and social issues associated with palm oil cultivation have been gaining traction globally.

The Malaysian Sustainable Palm Oil (MSPO) Certification Scheme is a national standard, designed to promotesustainable palm oil production in Malaysia. It serves as a framework for industry players to practice greater accountability towards the social, environmental and economic aspects of their activities.

The MSPO Certification Scheme consists of an accredited oil palm management and supply chain certification. SIRIM QAS is recognised as an MSPO Certification Body by the Malaysian Palm Oil Certification Council (MPOCC), ready to help certify palm oil plantations and supply chains against national requirements.

MS 2530 Malaysian Sustainable Palm Oil (MSPO) Certification Scheme

The MS 2530 standard outlines requirements for an oil palm management certification for plantation owners, smallholders and processing facilities. Audits will be done based on seven general principles which cover the following:

Principle 1	Management commitment and responsibility
Principle 2	Transparency
Principle 3	Compliance to legal requirements
Principle 4	Social responsibility, health, safety and employment conditions
Principle 5	Environment, natural resources, biodiversity and ecosystem services
Principle 6	Best practices
Principle 7	Development of new plantings



The Government of Malaysia has made it mandatory for growers and millers to obtain MSPO certification. Smallholders, estates and mills have the option to be certified individually or collectively.

Under group certification, they may apply for a single certification for a group of estates or a group of mills respectively, or a group consisting of a combination of smallholders and estates.

Certification provides assurance to supply chain partners that plantations are managed sustainably in terms of social, environmental and safety aspects. It also encourages better use of resources, leading to increased efficiency and the ability to deliver quality products consistently.



Malaysian Sustainable Palm Oil Supply Chain Certification Standard (MSPO SCCS)



The MSPO SCCS ensures traceability throughout the supply chain - from the raw materials to the manufacture and trade of palm oil and palm oil-based products. Through this certification, organisations can gain entry to export markets by complying with stricter regulations around sustainable production.

This applies to all relevant MSPO supply chain companies which include millers, refineries, oleochemical plants and food manufacturers.


Traceability is identified through two supply chain models. The Segregation (SG) Model requires certified palm oil products to be separated from uncertified products throughout the supply chain. The Mass Balance (MB) model allows for the mixing of MSPO and non-MSPO certified palm oil products at any stage. In both cases, the end-user can be assured that they are receiving sustainably sourced goods.


Certification Process: MSPO
