As an adventure tourism operator, you know how important it is to provide maximum fun and excitement with minimum risks to safeguard your customers from harm.



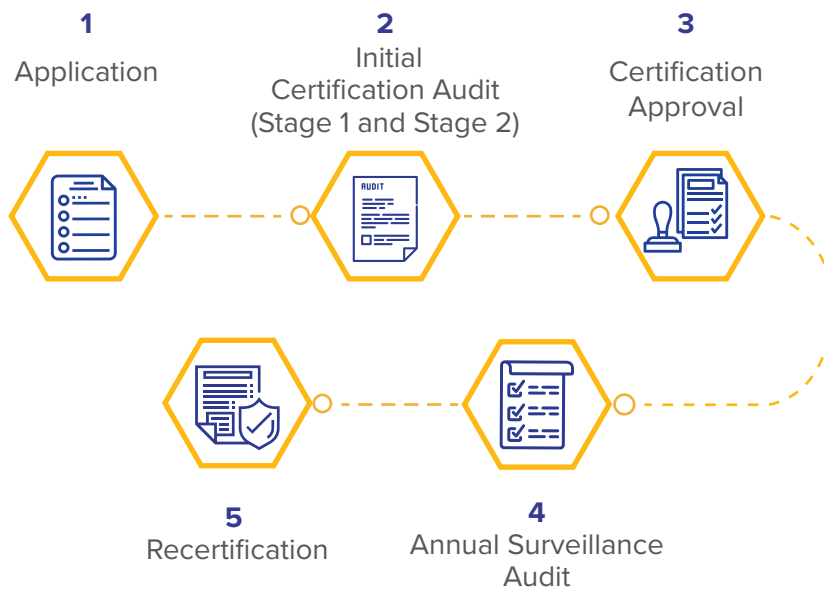
