## AKTA KASTAM 1967

## PERINTAH KASTAM (LARANGAN MENGENAI IMPORT) (PINDAAN) 2024

PADA menjalankan kuasa yang diberikan oleh subseksyen 31(1) Akta Kastam 1967 [Akta 235], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Larangan Mengenai Import) (Pindaan) 2024**.

(2) Perintah ini mula berkuat kuasa pada 1 Mei 2024.

**Pindaan Jadual Kedua**

2. Perintah Kastam (Larangan Mengenai Import) 2023 [P.U. (A) 117/2023], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam Jadual Kedua, dalam Bahagian I, II dan III, dengan menggantikan perkataan “Ministry of International Trade and Industry” di mana-mana jua terdapat dengan perkataan “Ministry of Investment, Trade and Industry”.

**Pindaan Jadual Keempat**

3. Perintah ibu dipinda dalam Jadual Keempat, dalam Bahagian I, berhubung dengan butiran 5, dalam ruang (2), dengan memasukkan selepas subbutiran (3) dan butir-butir yang berhubung dengannya dalam ruang (3) subbutiran dan butir-butir yang berikut:

## CUSTOMS ACT 1967

## CUSTOMS (PROHIBITION OF IMPORTS) (AMENDMENT) ORDER 2024

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Customs (Prohibition of Imports) (Amendment) Order 2024**.

(2) This Order comes into operation on 1 May 2024.

**Amendment of Second Schedule**

2. The Customs (Prohibition of Imports) Order 2023 [P.U. (A) 117/2023], which is referred to as the “principal Order” in this Order, is amended in the Second Schedule, in Parts I, II and III, by substituting for the words “Ministry of International Trade and Industry” wherever appearing the words “Ministry of Investment, Trade and Industry”.

**Amendment of Fourth Schedule**

3. The principal Order is amended in the Fourth Schedule, in Part I, in relation to item 5, in column (2), by inserting after subitem (3) and the particulars relating to it in column (3) the following subitems and particulars:
